The schedule of payments is a "cash basis" listing and therefore will differ from the expenses in the Districts' financial statements which are reported on an accrual basis resulting in timing differences. Furthermore, there are disbursements which are not considered expenses including payments made to other taxing authorities, acquisition of tangible capital assets and repayment of debt. In addition, there are expenses on the financial statements that do not involve the disbursement of cash such as amortization of tangible capital assets, contribution of tangible capital assets. Other reconciling items include civic grants as well as salaries and benefits already identified.
