10. MAYOR & COUNCIL BUSINESS

10.1 MAYOR AND COUNCIL REPORTS

Councillor Condon attended the Okanagan Regional Library Board meeting earlier this month. The Library is on target and on budget for current projects. There has been uptake in all performance standards over last year. West Kelowna's move to their new location is delayed to June 15. Councillor Condon also attended the Airport Advisory Board meeting. YLW has \$480 million worth of existing and future projects. Passenger numbers are expected to reach pre-Covid levels by the end of 2024.

Councillor Brophy revealed that Peachland will host a mini soccer tournament from June 24 to 29. This will be the first time Peachland kids will be able to play at home in 25 years. The boys' team was very successful at the Oliver tournament. Approximately 20% of our elementary-aged kids are signed up to play.

Councillor Ingram advised that Milly Marshall, the new Executive Coordinator of the Wellness Centre started this past Monday.

Councillor Thom attended the Make Water Work event in Lake Country, the carnival at Peachland Elementary and last week was interviewed by Global News about safety on Highway 97. We are trying to work with the Ministry of Transportation and Infrastructure to get safety improvements but unfortunately there have been recent fatalities.

Mayor Van Minsel recently returned from the Federation of Canadian Municipalities (FCM) Conference in Calgary, which had over 3,100 participants, making it the largest annual conference to date. The theme, "Redefining our Future", included workshops, panel discussions, and a trade show, fostering connections with colleagues and partners. FCM championed a new municipal growth framework which would help municipalities withstand current challenges. Keynote speakers included Prime Minister Justin Trudeau, Minister Sean Fraser, Conservative MP Scott Acheson, NDP Leader Jagmeet Singh and Green Party Leader Elizabeth May. Mayor Van Minsel also commended Councillor Glasman for representing Peachland so well at the conference.

Councillor Glasman also attended the FCM Conference and valued the learning opportunities it provided. She spoke on two resolutions and will present a report at the next meeting detailing those comments as well as the sessions and plenaries she attended.

Councillor Glasman extended condolences to the local family who lost their son in a recent motorcycle accident on Highway 97 and will continue advocating for speed limit changes to enhance community safety.

10.2 QUESTIONS BETWEEN COUNCIL MEMBERS/COUNCIL STATEMENTS

Councillor Condon:

Question regarding the vandalism at the dam and any consequences.

Shawn Grundy, Director of Operations noted that on May 31, vandals damaged the valve controlling the outflow from Silver Lake. The line was opened, causing the lake to start draining. A nearby property owners noticed, shut off the valve, and notified the District. The water loss does not affect the District's potable water supply, as it flows into the Trepanier Creek watershed, not the Peachland Creek watershed which supplies the drinking water. An RCMP report was filed, and new security measures are being implemented at Silver Lake and other upland lakes to prevent future incidents. This is a relatively uncommon occurrence, with it being the first time in 22 years at Silver Lake.

 A question had previously been posed regarding sidewalks on Sanderson Ave.

Jason Sandberg, Director of Engineering explained that although the sidewalk location may seem incorrect, it is within the correct road right-of-way (ROW). The sidewalk will be 1.5 meters wide and has been surveyed to ensure proper placement. The road ROW meets bylaw standards, so everything is in order.
